LOCKLEAR & ASSOCIATES, INC. FEE PROPOSAL FOR CR 250 RESURFACING DESIGN AND PERMITTING SERVICES

INTRODUCTION

Locklear & Associates, Inc. (L&A) is pleased to submit this fee proposal for providing the engineering, permitting and project management services needed for the resurfacing of CR 250, from CR 53 to the bridge replacement at the Suwannee River. The total length of the project is approximately 1.6 miles. This project is funded by an FDOT SCRAP grant, under FPID number 445820-1-54-01. The total grant allocation was \$1,146,042.00.

SCOPE OF WORK

The deliverables that are required under the Engineering Services contract are:

- Create a full design package, signed and sealed by a Professional Engineer licensed in the State of Florida, including contract plans, specifications, construction cost estimate, surveys, and any other reports, documents, or information relevant to this project and meet the requirements of the Florida Greenbook.
- 2. Copies of all required permits, including but not limited to FDOT, SRWMD and FDEP.

A detailed description of the anticipated tasks is provided as Appendix A.

COMPENSATION

Based on the understanding of the work activities described herein, our fee for design, permitting and project management for the execution of this design services contract is \$108,870. (A common planning value for design services is 10-15% of the construction amount. Our proposed fee is 9.5%)

Survey

Horizontal Project Control - includes researching datum records and existing maps, collecting field data on existing monumentation and maintained limits, establishing horizontal control points that are referenced to state plane coordinates and establishing a baseline of survey.

Vertical Project Control - includes researching vertical datum records and benchmark information and establishing vertical control points that are referenced to NAVO datum.

Topography/ DTM (3D) - includes the field survey work required to pick up select areas of topographical features and ground points. A survey of the entire corridor is not needed.

Processing data files - Includes the processing of the raw data files into CADD-compliant topographic drawings and Quality control reviews of the data.

Coordination - communication and action planning with Design staff and stakeholders.

Geotechnical Analysis

Pavement Cores – Collect several pavement cores throughout the project to get a good idea of the average existing pavement structure; asphalt, base and the ARMI layer.

Roadway Analysis

Typical Section analysis and selection - includes the review of the existing lane and shoulder widths, front slopes, traffic data and functional classification of the roadway. Analysis of this data and an understanding of the projected future use will result in the creation of a proposed Design Speed and typical section for the project.

Pavement Design analysis and selection - includes the collection of traffic loading data (including projected traffic for the design service year) and modulus numbers for the subgrade soils. Using this information, a required structural number will be established and a pavement design will be prepared in accordance with the *FOOT Flexible Pavement Design Manual*.

Evaluation of Critical Design Elements - includes an analysis of the design speed, lane widths, shoulder widths, bridge widths, horizontal alignment, super-elevation, vertical alignment, grade, stopping sight distance, cross slope and clear recovery area. These design criteria for these elements will be established and met if feasible. When any of the critical design elements cannot meet the established design criteria,

mitigation features will be added and a design exception will be prepared and approved by the Engineer of Record and the local government's designated authority.

Evaluation of drainage - includes the evaluation of existing surface water flow patterns and the need for drainage structures. Existing culverts will be evaluated for condition, horizontal clearance requirements, capacity, and safety treatments for the pipe ends. New culverts will be sized and added as required.

Quantities / Cost Estimates - includes the calculation of quantities, the analysis of local market conditions in establishing realistic unit prices and an estimate of the total project construction cost. This estimate will be created at the concept stage and will be updated at Phase II plans and at final plans.

Field reviews - includes field reviews needed to collect information and to meet with utility representatives or local stakeholders.

Technical Meetings (County, FOOT, Reg. Agencies) - travel and time spent meeting with County staff, FDOT and other stakeholders.

QA/QC - includes continuous quality control checks by front-line supervisors, internal peer review by our senior Engineers and constructability reviews by our senior CEI staff.

Coordination - communication and action planning with owners, Design staff and stakeholders. Includes coordination with FDOT for plans reviews and invoicing support.

Roadway Plans Production

Key Sheet - preparation of the key sheet, in general conformance with the FDOT FDM.

Typical Sections - preparation of typical sections, in general conformance with the FDOT FDM.

LAFAYETTE COUNTY AND SUWANNEE COUNTY FOR VETERANS SERVICES

THIS AGREEMENT, made and entered into this day of Wallow, 2023, by and between Lafayette County, a political subdivision of the State of Florida, by and through the Board of County Commissioners, hereinafter referred to as "Lafayette County," and Suwannee County, a political subdivision of the State of Florida, by and through the Board of County Commissioners, hereinafter referred to as "Suwannee County," hereinafter collectively referred to as the "Parties:"

WITNESSETH:

Whereas, the Parties employ a Veteran Services Official whose duties include, but are not limited to, offering professional resources to all members of the armed forces of the United States – former, present and future – including those with service connected and non-service connected disabilities; and

Whereas, the Parties desire to enter an agreement for Suwannee County to provide Veteran Services to Lafayette County in the event of the incapacity, absence, or unavailability of the Lafayette County's Veteran Services Official, and

Whereas, Suwannee County is willing to assist with such services whenever such assistance can be provided on an as needed basis by its Veterans Services Official without impairing the operation of the Suwannee County's Veteran Services Department.

It is therefore agreed by and between the Parties as follows:

- 1. Lafayette County may from time to time request veteran services by the Suwannee County Veteran Services Department. Such requests shall be made to the Veteran Services Official. If authorized by the Veteran Services Official, services rendered shall be as an agent of Lafayette County, as the entity requesting the service.
- 2. This Agreement shall continue from the date of execution hereof, and time to time, until cancelled by either of the Parties. Either party may cancel the Agreement by seven (7) days written notice to the other party.
- 3. Lafayette County hereby designates the Suwannee County Veteran Services Official as its own temporary Veteran Services Official. Any services rendered by a Suwannee employee, at the request of Lafayette

County, shall be made by said employee as an agent of the party requesting the service. Any liability for his/her acts or omissions to act in carrying out veteran services for the entity shall be borne by the entity requesting service. However, the Suwannee County Veteran Services Official shall not be an employee of Lafayette County.

- 4. A fee for such service as agreed between the Parties is as follows:
 - a. Basic Fee per hour \$25.00; and
 - b. Mileage, at a rate of \$.585 per mile.

The above rates will be revisited on an annual basis for the duration of the contract, and any agreed changes thereto shall be noted by appropriate addendum.

5. This Agreement shall be effective the day and year first above written.
