The meeting was held in the County Commissioners Meeting Room at the Lafayette County Courthouse in Mayo, Florida. APPROVE THE MINUTES

On a motion by Mr. Lamb and a second by Mr. Byrd, the Board voted unanimously to approve the minutes.

BILL ALDERMAN ZONING ISSUE

Mr. William "Bill" Alderman appeared before the Board. Mr. Alderman discussed his property on SW Carber Road. He explained to the Board how he would like to rezone a portion of the property. The Board asked Mr. Alderman to come to the meeting September 26, 2023, when the Zoning Official would be in attendance to discuss the issue.

DANIEL BENNETT RESIGNATION

On a motion by Mr. Lamb and a second by Mr. Byrd, the Board voted unanimously to accept Daniel Bennett's resignation. On a motion by Mr. Byrd and a second by Mrs. Walker, the Board voted unanimously to advertise the position at \$14.00 per hour.

JAIL RENOVATION AGREEMENT

On a motion by Mr. Adams and a second by Mr. Lamb, the Board voted unanimously to approve the agreement with the State of Florida, Office of Criminal Justice Grants, Florida Department of Law Enforcement. This agreement relates to the funds in Specific Appropriation 1281A, \$4,000,000.00 in nonrecurring fixed capital outlay funds are provided to Lafayette County Board of Commissioners on behalf of Lafayette County Sherrif's Office for the Lafayette County Sherriff's Office Jail project.

DEBRIS CONTRACT RENEWAL

On a motion by Mr. Lamb and a second by Mr. Adams, the Board voted unanimously to renew their contract with Grubbs Emergency Services, LLC for debris removal services. This renewal will extend the contract until October 08, 2024.

SOLID WASTE AGREEMENT

On a motion by Mr. Byrd and a second by Mrs. Walker, the Board voted unanimously to approve the Solid Waste Agreement with the Florida Department of Environmental Protection. This agreement will assist Lafayette County with expenditures in the Solid Waste Department in Fiscal Year 2024.
