

REORGANIZATION MEETING

NOVEMBER 14, 2023

9:00 A.M.

The annual reorganization meeting of the Lafayette County Board of County Commissioners was held on November 14, 2023 at 9:00 a.m. with the following members present: Lance Lamb, Dist. 1; Mason Byrd, Dist. 2; Lisa Walker, Dist. 3; Anthony Adams, Dist. 4; Earnest L. Jones, Dist. 5; and Leenette McMillan-Fredriksson, County Attorney.

The meeting was called to order by Steve Land, Clerk of Court. The floor was opened for nominations for Chairman. Mr. Lamb nominated Mr. Jones for Chairman. On a motion by Mr. Lamb and a second by Mrs. Walker, the board voted unanimously for nominations to cease. The Board unanimously elected Mr. Jones as Chairman. Mr. Jones assumed the duties of the Chair. The floor was opened for nominations for Vice-Chairman. Mr. Lamb nominated Mr. Adams. On a motion by Mr. Byrd and a second by Mr. Byrd, the board voted unanimously for nominations to cease. The Board unanimously elected Mr. Adams as Vice-Chairman.

On a motion by Mr. Lamb and a second by Mr. Adams, the Board voted unanimously to keep the representatives to various Board positions the same which includes the following – Mr. Anthony Adams to the North Florida Regional Planning Council Board; Mr. Mason Byrd to the Economic Development Partnership; Mr. Earnest Jones and Mr. Anthony Adams to the Small County Coalition Board; Mr. Lance Lamb to the Three Rivers Regional Library Board; Mr. Mason Byrd to the Transportation Disadvantage Health Planning Council; Mr. Anthony Adams to the Local Technology Planning Team Committee; Mrs. Lisa Walker to the Advisory Council for North Florida Medical Centers; and Mrs. Lisa Walker to the Career Source North Florida Board.

On a motion by Mr. Byrd and a second by Mrs. Walker, the Board voted unanimously to re-hire all Department Heads which include the following: Scott Sadler as Public Works Director; Garret Land as Building/Zoning Official; Marcus Calhoun as County Maintenance; Marty Tompkins as EMS Director; and Deborah Johnson as County Library Manager.

On a motion by Mrs. Walker and a second by Mrs. Byrd, the Board voted unanimously to re-hire all Custodians which include the following: Alicia Swinson at the

Day Community Center; Helen Bennett at the Airline Community Center and the Mayo Community Center; Fourth District Community Center which is currently out for advertisement; and Olga Reyes at the Courthouse and the Extension Office.

On a motion by Mr. Adams and a second by Mrs. Walker, the Board voted unanimously to re-hire all positions that are under the Department Heads.

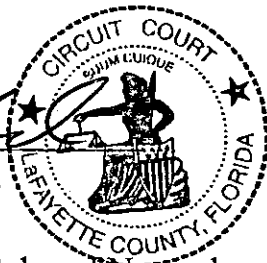
