## APPROVE THE MINUTES

On a motion by Mr. Lamb and a second by Mr. Byrd, the Board voted unanimously to approve the minutes as presented.

#### ROAD RESURFACING DEPARTMENT OF TRANSPORTATION

On a motion by Mr. Adams and a second by Mr. Byrd, the Board voted unanimously to submit the following three roads to the department of transportation for consideration, for the SCRAP and SCOP programs, CR 350, CR 348, and CR 357.

#### ROAD DEPARTMENT

On a motion by Mr. Lamb and a second by Mr. Adams, the Board voted unanimously to hire Mr. Sadlers recommendation, Bruce Wimberley for the open position at the Road Department.

### **RESOLUTION NUMBER 2023-12-02**

On a motion by Mr. Adams and a second by Mr. Byrd, the Board voted unanimously to read Resolution Number 2023-12-02 by title only. On a motion by Mr. Adams and a second by Mr. Lamb, the Board voted unanimously to approve Resolution Number 2023-12-02 extending the Local State of Emergency due to Hurricane Idalia.

# **EDWARD PERRY SPORTS COMPLEX**

The Board opened a sealed bid for 24 pieces of 4" schedule 40 galvanized pipe to improve a chain link backstop at the Edward Perry Sports Complex. The only bid submitted was from Suwannee Iron Works for \$11,520.00. On a motion by Mr. Lamb and a second by Mr. Byrd, the Board voted unanimously to award the bid to Suwannee Iron Works.

The Board opened a sealed bid for three-strand twisted knotted twine- made into a net with a 1-3/4" x 1-3/4" mesh opening-on the square. UV and abrasion coated black with a black 3/8" hollow braid rope border on all four sides for new netting at the Edward Perry Sports Complex. There were two bids submitted: Suwannee Iron Works for \$12,592.85 and The Net House for \$6,786.00. On a motion by Mr. Adams and a second by Mr. Byrd, the Board voted unanimously to award the bid to The Net House.
