APPROVE THE MINUTES

On a motion by Mr. Adams and a second by Mrs. Walker, the Board voted unanimously to approve the minutes as presented.

PRESENTATION BY VOLKERT, INC.

Mr. DeWayne Ray, Mr. Arthur Hooks and Mr. Mike Warnke presented the Board with some information about their engineering firm, Volkert, Inc.. Volkert can provide numerous services to Lafayette County including Engineering/CEI, Environmental and Planning assistance. The Board thanked them for the presentation and told them they looked forward to working with their firm.

ADVERTISE FOR COLLECTION SITE SUBS
