The annual reorganization meeting of the Lafayette County Board of County Commissioners was held on November 20, 2018 at 9:00 a.m. with the following members present: Lance Lamb, Dist. 1; Henry McCray, Dist. 2; Lisa Walker, Dist. 3; Anthony Adams, Dist. 4; Earnest L. Jones, Dist. 5.

The meeting was called to order by Steve Land, Clerk of Court. The floor was opened for nominations for Chairman. Mr. Jones nominated Mr. Adams for Chairman and Mrs. Walker seconded the motion. On a motion by Mr. Jones and a second by Mr. Lamb, the board voted unanimously for nominations to cease. The Board unanimously elected Mr. Adams as Chairman. The floor was opened for nominations for Vice-Chairman. Mr. Jones nominated Mr. Lamb and Mrs. Walker seconded the motion. On a motion by Mr. Jones and a second by Mrs. Walker, the board voted unanimously for nominations to cease. The Board unanimously elected Mr. Lamb as Vice-Chairman.

On a motion by Mr. Lamb and a second by Mr. Jones, the Board voted unanimously to appoint Mrs. Walker to the Transportation Disadvantage Health Planning Council.

On a motion by Mr. Lamb and a second by Mr. Jones, the Board voted unanimously to have Mr. Adams continue as the representative to the North Florida Regional Planning Council Board.

On a motion by Mr. Lamb and a second by Mr. Jones, the Board voted unanimously to have Mr. McCray as representative to the Economic Development Board.

On a motion by Mr. Lamb and a second by Mr. Jones, the Board voted unanimously to keep Mr. Adams and Mr. Jones as the Lafayette County representatives to the Small County Coalition Board.

On a motion by Mr. Lamb and a second by Mr. Jones, the Board voted unanimously to have Mr. Lamb continue as the representative to the Three Rivers Regional Library Board.

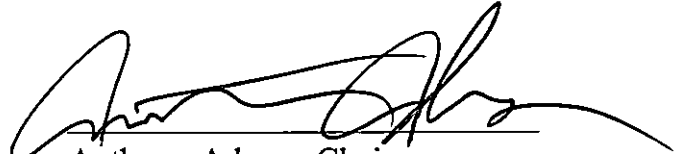

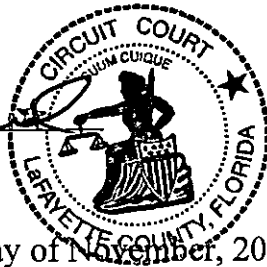
**ADJOURN**
