### TROPICAL STORM NICOLE

The Board was updated on the latest information concerning Tropical Storm Nicole. The anticipated strength, track and timing were all discussed. On a motion by Mr. Jones and a second by Mrs. Walker, the Board voted unanimously to approve Resolution Number 2022-11-01, declaring a state of emergency.

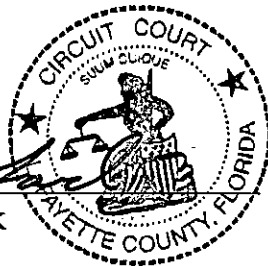
### ADJOURN

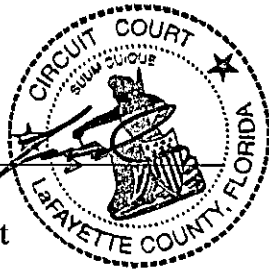
