The meeting was held in the County Commissioners Meeting Room at the Lafayette County Courthouse in Mayo, Florida. BOARD OF ADJUSTMENTS MEETING

RESOLUTION NO. BA V 21-01

On a motion by Mr. Jones and a second by Mrs. Walker, the Board voted unanimously to have Mrs. McMillan-Fredriksson read Resolution No. BA V 21-01 by title only. COVID-19 STATE OF EMERGENCY FOR LAFAYETTE COUNTY


